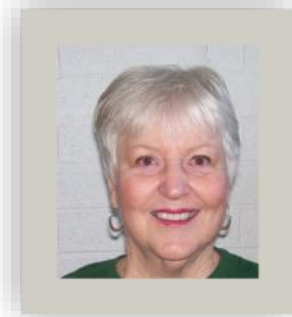

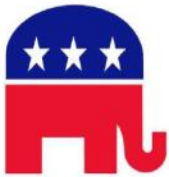

London Bridge Republican Women**26 Club Fundraising Rules of the Game**

The board of London Bridge Republican Women discussed and agreed to hold the 26 Club Fundraiser for 2026 at the December 30, 2025 Board meeting.

The details of the game are as follows:

Ticket Sales (number, dates, price and member responsibility)

- Beginning with the Feb. 2, 2026 General Meeting a total of 450 tickets will be printed and available for purchase
- Ticket Sales will run from Feb. 2, 2026 thru Sept. 14, 2026, or until all are sold.
- Tickets can only be sold in this time period and will cease prior to the 1st drawing on Oct. 5, 2026, with a limit of 450 tickets, according to Arizona Statutes.
- Ticket price is \$25 each.
- Members are asked to be responsible for selling 4 tickets each.

Drawings (number, schedule, type)

- The drawings will begin on Oct 5, 2026, with the final drawings to be held on Sept. 2025 (the actual drawing schedule is available).

Council Corner by David Diaz, Vice Mayor

The following is a brief update of current happenings with regards to Lake Havasu City and your City Council.

Annexation of Sheriff Substation. The City is working with Mohave County on the proposed annexation of 3500 Hwy 95 N, which is the former Mohave County Sheriff's substation. The City Council will hear the item on the agenda for January 27th and determine if we should proceed. Annexing the property would bring more highway frontage into the City's municipal boundary.

Ironman. Go Lake Havasu was courting Ironman to come to Lake Havasu City, in November of next year. After several meetings and discussions, and looking at a variety of routes, it was determined we are simply not a good location for the event. Just the bike portion of the event is 112 miles, making it very difficult to plan a course that doesn't significantly negatively impact our residents. Closing down sections of Highway 95 and a few neighborhoods is a concern for our residents. The biggest obstacle to overcome was manpower.

SARA Park Dog Park. The parking lot at the dog park is new and improved. The Public Works team put down millings to replace the dirt parking lot. We ran into a few snags that delayed the project, but it is now striped and open to the public.

Council Planning Session. This year's retreat is being held at Shugrues in the Bridge View Room. The date of the retreat is Thursday Jan 22 from 8AM - 5PM. The public is invited to attend.

Used Oil and Fuel Recycling. We are working with Republic Services to install a location at the landfill to allow our residents to safely dispose of used oil, fuel and antifreeze. We are a community full of toys that run on fuel and oil. Ever since a few of our local auto shops stopped accepting used oil, several residents reached out to the City asking us to help fill that void. In partnership with the City, Republic Services agreed to locate two large containers at the landfill to collect the liquids. I expect a big demand for this service. It's all setup as a 6-month pilot program, so we can evaluate the success of the program in a few months.

Citizen Survey. The surveys are going out this week to approximately 3,000 households. This is a wonderful way to solicit the feedback we need from our residents to guide our actions. The results will be presented to the City Council in March.

Anderson Power Sports. We received an application for an At-Risk Grading Permit for their property located at 5601 Highway 95, otherwise know as the "Kiowa Ponds". The application is in the plan review stage.

Back Nine Golf. The tenant located at 1850 McCulloch Blvd N. (Bldg. B, Unit 1) was issued a permit for tenant improvements, including four golf simulators and a lounge area.

Split Finger Athletics. A permit was issued for tenant improvements at 5601 Highway 95 (Bldg. F) that includes indoor and outdoor batting cages and a training center with a gym area. This is the old Win Win Bingo location at The Shops.

Rock Wall Rezone. Remember the rezone that the City Council approved several months back allowing for the construction of a rock wall, miniature golf course and an arcade? The owner's plans changed. They are coming back to the City asking for a rezone, to revert back to the previous zoning. We are being told that the proposed use will be related to the sale of trucks and commercial equipment.

Again, the LHC City Council is here to serve you, the residents of our great city. Feel free to contact me at anytime.

A Gift Of Freedom

January 2026

The world was told by the Biden Department of Justice and the media that I was the Commander of the Oath Keepers militia and the mastermind of a plan to attack the Capitol and overthrow the government. They piled phony accusations on top of phony accusations against me — a disabled veteran and retired Navy officer living quietly on my generational family farm in Virginia.

All of these charges were totally false. As would be every new charge invented by the government.

And the DOJ and FBI, even as they attacked our farm in the frosty January darkness with armored vehicles and armored thugs, knew they were false. But they didn't care.

That should be chilling to every American.

My name is Thomas Caldwell and I am a Christian. I am also a retired Navy Lieutenant Commander who served our nation for nearly two decades in the Intelligence Community. My wife, Sharon, and I spent years running a successful software company serving federal agencies ranging from the Department of Housing and Urban Development to the U.S. Coast Guard. We were living peacefully on our small family farm in Virginia's Shenandoah Valley when freedom was snatched from us. Freedom. That and so much more.

I watched helplessly that morning, chained hand and foot, as the bumbling FBI nearly murdered my wife on

our front porch. What followed was my arrest for crimes I never committed, solitary confinement in an icy dungeon, horrific tortures and a nearly 5-year battle through a perverted legal system determined to crush everything Sharon and I had built in our lives together.

Physically broken, I was temporarily released to a cage without bars. Confined to our property with an ankle monitor, always watched, forbidden by “the court” to have normal contact with friends, family and, in fact, the outside world. No access to a cell phone, the internet, social media or a computer. Deprived of the freedom of movement, forced to beg permission well in advance from haughty prosecutors and a fickle judge for attendance even at Church services. Freedom to attend weddings, birthdays, anniversaries, seasonal celebrations, visits to nursing homes and hospitals, even funerals denied. Family and relationships lost.

Silenced. “Don’t you dare speak in public, filthy insurrectionist!” And when I did, it was food for the ravenous lawfare machine which quashed, manipulated and lied about my faith-filled words. Fodder for the cannons of hatred. “Guilty” — and no one would listen to the truth of my innocence.

Life, liberty, happiness, freedom to worship and freedom of speech all denied. Aren’t they, along with truth, the foundations of America itself?

Could this happen in our country? It did. I’m just one person to tell you about it.

Whether on a cold prison floor, in a terrible 10-week long secretive and rigged trial or suffering on the edge of life imprisonment for years, the tougher the situation, the more God revealed Himself and His love to my wife Sharon and me. When there was no hope, we found hope in fervent prayer and in the study of His Word, the Holy Bible. In the darkest and most frightening parts of my life and maybe only in those times, I was the most receptive to Him.

While America has no idea of the carnage wrought by our own government, I wondered if people still read books.

I wrote **“The Mouths of the Wicked: A True January 6 Story of Corruption, Persecution, Survival and Victory,”** over the years of torment as events unfolded — not as a retrospective in the warm light of the victory God would provide. I wanted to share with my fellow citizens my real-world Christian adventure story filled with tragedy, anxiety, miracles, and victory. I wrote it as a friend, your friend, speaking frankly — a testament of faith over fear.

My wife and I learned that you can work hard, treat others as you wish to be treated, play by the rules, pay your taxes, say your prayers and still be targeted by those with unchecked power operating under the cloak of “absolute immunity.” That Supreme Court-upheld notion that government lawyers and judges, regardless of how corrupt they may be, can lie, break the law, violate constitutional, civil and human rights all completely free of confoundment or consequence.

Long before President Trump’s blessed pardons for most (but not all) J6ers, I was acquitted of three conspiracy felonies at trial and the Supreme Court threw out another false charge against me.

This past Christmas, at home on our windswept farm, Sharon and I spoke reverently of God’s strength and provision within the storm. All glory belongs to He who delivered us against all odds. Loosed from oppression and threats, the season was one of peace, praise, and reflection.

While health and reputation and fortune are forever lost to the crumbling fantasy version of January 6, for my wife and me and for hundreds of falsely charged and overcharged citizens, a most wonderful gift this Christmas was that of freedom. No longer a “right,” if a despotic government can snatch it away as it has and will again.

Freedom in our land is what it has always been: a precious gift from God. I am thankful, Father.

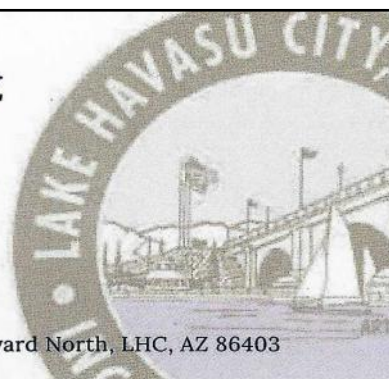

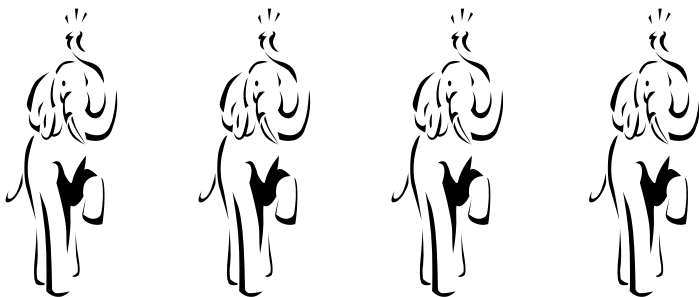

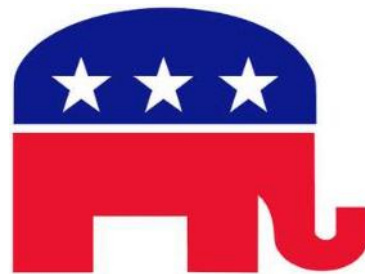
