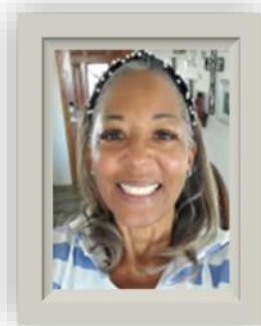

## 'Let's bioengineer the ticks to make people allergic to red meat!'

Should the government be able to make you sick — for “your own good”?

Yes, say two Michigan bioethicists, Parker Crutchfield and Blake Hereth. Writing in the July issue of *Bioethics*, the duo argue that we should genetically modify ticks to spread an intolerance to eating red meat.

This has nothing to do with your health. In fact, the *goal* is to make you sick. The authors claim that their plan is in service of “public health,” but what they mean is the “health” of the *planet*. You, dear reader, are collateral damage.

Too many people eat too much beef, they argue. Since not enough people are voluntarily giving up steaks and burgers, Crutchfield and Hereth want to “nudge” them by weaponizing a condition called alpha-gal syndrome (AGS) — a tick-borne allergy that makes eating red meat trigger anything from intestinal distress to nausea to anaphylaxis. The authors downplay the severity: Anaphylaxis is “rare,” they assure us, while other symptoms are merely “uncomfortable.” But the goal is clear: Punish the human body until it complies.

This isn't public health. It's public harm — deliberate, engineered, and ideological. Crutchfield and Hereth are environmental ideologues, and their disdain for human autonomy is chilling. In their view, if you won't stop eating meat for the sake of the planet or the cow, they'll make you stop for the sake of your stomach.

They don't bother to argue why eating beef is inherently immoral. They simply decree that red meat consumption is unacceptable, since that is the consensus of the people they respect. And if humans won't change voluntarily, then they'll engineer disease to force compliance.

Their rationalizations stumble into absurdity. They admit that forcibly injecting people with AGS would raise “normative concerns.” So instead, they propose a “natural” workaround: genetically enhanced ticks that don't carry *other* diseases, survive in broader environments (like cities), and conveniently infect people *by accident*. It's not coercion, they say; it's just bad luck if a tick bites you.

This is not new. Crutchfield previously argued that “moral enhancement” of the population ought to be covert — without public awareness. It's not just dystopian; it's deeply unethical. Under the guise of “bioethics,” these authors promote compulsory moral engineering: You don't have to know, consent, or agree. You just have to suffer.

Let's call things what they are: Crutchfield and Hereth are proposing war crimes.

That is not hyperbole. Here's why:

**First**, 2025 marks the 80th anniversary of the Nuremberg War Crimes Trials, where German physicians were tried for performing involuntary experiments and euthanasia in the name of “public health.” One of the core principles to emerge from Nuremberg is that *no intervention may be made in a person's body without his knowledge and consent*. Crutchfield and Hereth violate that principle outright.

**Second**, the use of genetically modified organisms (in this case, ticks) to spread disease is a form of bio-chemical warfare. If individuals released disease-spreading insects to harm others, we'd prosecute them as terrorists. The idea that a government or “public institution” might do so in the name of climate or health policy doesn't make it less criminal — it makes it more dangerous. It also shatters (and rightly so) *any* public trust in such a “community.”

**Third**, Crutchfield and Hereth are neo-eugenicists. A century ago, American elites — including the notorious Margaret Sanger — advocated mandatory sterilization to “improve” the genetic stock of the nation. Today's bioethicists push for the genetic reprogramming of human metabolism to enforce their elite vision of what's “good for us.”

These are not idle academic musings. In 1920, two German academics, Karl Binding and Alfred Hoche, developed the idea of “*lebensunwertes Leben*” (“a life unworthy of life”). Within two decades, those “ideas” became official German public policy. What began in lecture halls ended in gas chambers, with six million-plus corpses.

Ideas have consequences. Americans cannot afford to treat this lightly. Crutchfield's and Hereth's proposal to weaponize ticks to re-engineer human behavior is not merely immoral; it is tyrannical. It must be condemned for what it is: an assault on human dignity, freedom, and life itself.

**Parking Lots.** LHC Public Works team completed work on two more parking lots. In addition to the recent completion of the parking lot at London Bridge Beach Park and the overflow lot at Cypress Park, we also completed many other parking lots in our community in the last few months, including Jack Hardy Park, Pima Square, Dick Samp Park and Avalon Park.

**Citizen Survey.** In recent years, LHC has conducted a citizen survey every other year, and it's that time again. The questions in the survey are largely the same each time, giving us the ability to compare results to previous years and other cities and towns across the country. There might be some additional new questions coming in this year's survey due to much that is happening now and in the future of our city. Stay tuned for the upcoming survey and please participate.

**Local Bids.** We have several solicitations for bids posted on the City's website, including the outdoor pool, and the bathroom and concession building at Main Street Commons. Based on our progress, we hope to receive the 30% design from our contractor in mid-September. The next presentation to the City Council is scheduled for the first meeting in October, where the City Council and the public will be updated on this important project.

**Havasu Works Video Series.** We are introducing a new video series to increase awareness of City projects for LHC residents. The videos will highlight our ongoing capital projects, the people behind the work, and the impact these projects will have on our daily lives.

**Sidewalks in the Downtown.** The Public Works team pressure washed the sidewalks in the downtown and conducted some general cleanup. It was the first time we did that in many years and we now have the biggest used gum collection in history. LHC Public Works team will continue this routine every six months going forward.

## Legislative Update for August 2025

Arizona's legislature sine die'd on June 27, 2025. All laws passed in the legislature and signed by the Governor are effective September 26, 2025.

This year lawmakers introduced 1,724 bills in total, 439 of those bills made it to the Governor's desk, with only 265 bills signed into law by Governor Hobbs. Governor Hobbs vetoed 174 bills.

18 of the vetoed bills were repeats from 2023 and 2024, reintroduced from Republicans, most without any significant changes. They cover a range of issues, including elections, firearms, LGBTQ+ rights and school boards.

Despite the 18 repeat bills that were vetoed, almost all of the legislation Hobbs signed this session came from Republicans. Democrats only got 10 bills out of the Legislature this year, seven of which came from the House and three from the Senate.

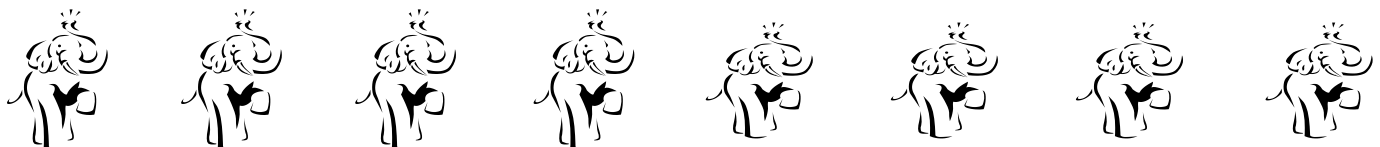
Senator Shawna Bolick, R-Phoenix, takes home the title of most bills signed by a single lawmaker at 16. Republican Senator J.D. Mesnard and Republican Senator David Gowan tied for second place, each with 15 bills signed by Hobbs. On the Democratic side, Rep. Alma Hernandez, D-Tucson, had the most bills signed in her caucus at four.

There are not always winners in this legislative game though, Republican House Representative Gail Griffin, had the most bills vetoed by the governor for the second year in a row, at 18. Republican Senator Jake Hoffman and Republican Senator Wendy Rogers tied for second-most vetoes with each reaching 12 rejections.

Surprisingly enough, 10 signed bills drew directly from testimony produced by groups including the Heritage Foundation and Turning Point USA. Hobbs had been briefed on their origins and some versions were already being used to implement policies in other states, so she signed. These bills were passed with varying levels of bipartisan support, such as HB 2112 and 2195, aimed at restricting pornographic content online and in youth-targeted apps. HB2679, which allows utility companies to offset coal-related debts by charging renewable energy users.

We would be remiss to not thank our own Representative; Leo Biasiucci who was inspired by a California law restricting school lunches with artificial dyes. Representative Biasiucci pushed HB2164, which bans "ultra-processed" foods in schools.

It looks as if Hobbs' actions of signing many Republican bills was done to position her for her next re-election campaign, focusing on signing bills with a bipartisan vote. As dedicated Republicans we need to work extra hard this next election season to get a Republican in the governor's chair so this game of partisan politics is won by us.

## Trump's chip deal with Nvidia and AMD addresses a long-standing China problem

When President Trump announced that Nvidia and AMD would have to turn over 15 percent of their China sales to the U.S. government in exchange for export licenses, the experts were quick to cry foul. They called it unorthodox. They called it unconstitutional. Some even called it a shake-down of private business. What they have not done is connect this move to the much larger story that has been unfolding for decades: China's systematic theft of American technology.

For years, China has been building its industries not just on its own innovation but on what it has stolen from the United States. The tools have varied. Sometimes it was through forced partnerships where American firms had to share technology in order to operate in China. Sometimes it was cyber theft carried out directly by state-backed hackers. Sometimes it was old-fashioned industrial espionage. However it happened, the result was the same. American companies lost. China gained. Independent estimates put the cost at between 225 billion and 600 billion dollars a year. That is not a rounding error. That is an enormous drain on our economy.

Seen in that light, Trump's deal looks less like an abuse of power and more like a crude attempt to claw something back. Instead of allowing China to take American innovation without consequence, this arrangement forces companies to give a portion of their China profits back to the United States. It may be messy. It may be challenged in court. But it is at least aimed at rebalancing a relationship that has been tilted against America for far too long.

What bothers me is how the commentary leaves this context out. The press treats the deal as though it appeared in a vacuum. Trade experts debate the legality as if that is the only issue. They do not ask whether it is just. They do not ask whether it is long overdue for the United States to stop pretending that trade with China has ever been free and fair.

What few seem to point out is that Nvidia and AMD are unlikely to absorb the cost of this new arrangement themselves. Like any savvy business, they will pass it along to their buyers. In other words, China will end up paying higher prices for the same chips, effectively funding the 15 percent tribute that now goes to Washington. Given how vital these processors are to Beijing's AI and supercomputing ambitions, Chinese buyers will grit their teeth and pay. In this light, the deal looks less like a shakedown of American firms and more like a clever mechanism for shifting the burden of China's own bad behavior back onto China.

This is not a perfect policy. It probably will not be the final policy. But it does force us to confront the reality that the old rules are broken. For too long we have allowed ourselves to be played. We told ourselves the world was operating on one set of rules, when in fact China was playing by another. Trump's approach may be unpolished, but it puts the problem in the open.

We cannot talk about semiconductors and trade with China as if the past thirty years never happened. We cannot ignore the hundreds of billions stolen and the industries hollowed out. Until we face that, every policy will look odd and every attempt to get leverage back will be dismissed as reckless. It is time to admit what has been happening. Only then can we decide what should come next.

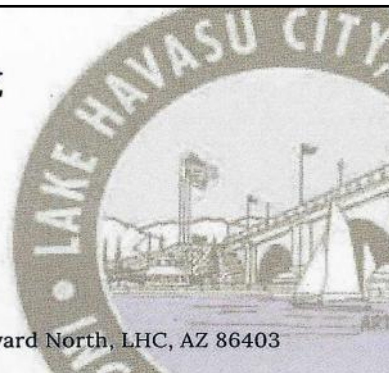

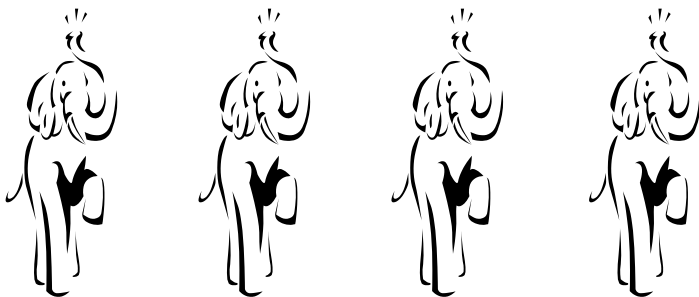

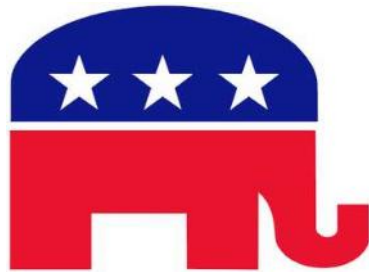
