PRESIDENT - KATHY ELLSWORTH

With so many senior members of our club it has been on my heart to warn of phishing and other types of scams that we are bombarded with these days.

I'm betting all of us have received at least one email, phone call or text that was clearly a scam. As I've mentioned many times before, I watch a lot of stuff on YouTube. Some of the podcasts I watch are about people, mostly older women, being scammed and how the podcaster works to foil the intent of the current scammer

he is communicating with. I've included links to these podcasters at the bottom of this article. They are fascinating, as well as informative.

First some examples of scams and the tipoff that they are scams and how to handle them.

You receive an email or phone call from the IRS or Social Security Administration (supposedly), telling you that you owe money for unpaid taxes or over paid Social Security benefits.

- The scammer preys on the panic we feel, using the very values we were taught against us. They do not give the victim a chance to think about this or even check their records to find the error, because if they did the victim learn the truth.
- This is NOT how these agencies operate, they will never phone you or send a scary email to demand money. Instead they will mail an official notice by mail containing a reference #, phone # to call for more information and clear instructions. They will give a deadline for response and opportunity to deny their claim.
- As soon as you believe it's a scam, hang-up on them, look up and call the agency they claim to represent. Don't continue to communicate with the scammer and in fact, block their phone #.
- Clue it is a scam: a scammer may request payment by Bit Coin, Gift Cards or CASH (mailed to an unofficial address), because these are untraceable payment types.

You get a payment confirmation email from "PayPal" for anything from new iPhones, to anti-virus software.

- Look very closely at the email address used. I've found it easier to see if I do a reply to see it (of course I delete this and do not actually send the reply).
- They can make things look very authentic, but take the time to examine the email and content. DO NOT click any link or send a response, of ANY KIND. Responding alerts them that the email account is active and they may in turn sell your information to other scammers on the Black Web. Report to your email provider and send to SPAM/JUNK and Block it to prevent receiving more.

You get an email from a friend or relative requesting money because they are in a tough bind and need money immediately.

- Don't respond to the email, but instead contact that person by phone or a known email account. You can also **FORWARD** the email to them so they can warn their contacts about this.

This is a very sad type, it's called "Catfishing" or Romance Scam. You are contacted on a dating site, Facebook or by email about someone looking for companionship. Their profile picture will be of a very attractive man or woman. They will chat with you and tell you everything you want to hear before they start asking for money to be sent to them, often via an unrelated address in CASH.

- This may sound terrible on my part, but first, take a look at your profile picture, or in the mirror. I've done online dating and I know a guy would never contact an ordinary looking person legitimately.
- If you know how to use an app like Google Lens take a picture of their profile picture to see if the results lead you to a completely different person, than who they are claiming to be. Often a picture is pulled from someone's profile on FB and a different name used for the made up profile.

A new scam is the Jury Duty scam. The victim receives a phone call from someone sounding very official, saying there is a warrant out for their arrest because they didn't respond to their jury duty call. How they find people that actually have received jury duty notices is unknown.

- They threaten the victim with arrests by police if they don't respond to their demands.
- The victim is told to pay in a very unofficial way or location, typically by Bit Coin.

The tip off on all of these are: A. the urgency of response demanded, B. the use of bitcoin, gift cards or sending of actual cash (sometimes thousands of dollars), C. the use of American names, but have a Indian or Pakistani accent. Above all **DO NOT RESPOND** to the scammer. Hang up or block their email or FB profile.

Council's Corner: Compliments of David Diaz

Greetings to all of the great patriotic members of the London Bridge Republican Women's Club. As I continue to represent you on the City Council along with my fellow Council Members, please feel free to contact me at anytime for any further information you feel relevant or need clarity on.

Plans Submitted: Panera Bread officially submitted their plans to build a new restaurant on McCulloch Boulevard, located between PMG Manufacturing (old Kmart) and the Mohave County Library. The owners of the Yard City property in the downtown submitted plans for a three-story bar/restaurant/nightclub. The new tenant at the old Burger King building is Amigo's Red Tacos, a franchise based out of Southern California. Great reviews so far. Work on the new Buffalo Wild Wings seems to be slow, but steady. Additionally, work continues on other local restaurants that are either relocating or opening a second location, including

El Parisio and Loco's Bar and Cocina. Both of these are now open. There is talk in the community about a new Broken Yolk breakfast restaurant, to be located in the building where El Parisio used to be, but we have not received any plans.

Water Lab Building: Bids came in for the construction of our new Water Laboratory at the Mulberry Treatment Plant. Unfortunately, they came in way over budget, The Public Works Team is reworking the design and developing strategies before we advertise the project again.

Upgrades to Traffic Signals. We updated our traffic signals at three major intersections in town. Lake Havasu Avenue and Industrial Boulevard, Palo Verde Boulevard South and Lake Havasu Ave and McCulloch Blvd and Smoketree Avenue.

CIP Videos. We are starting the process of creating one to two videos each month dedicated to our Capital Improvement Plan projects. These videos will inform the public, Council or anyone interested in the progress of our projects that are under design or construction. It adds to our existing library of videos, including Faces of Havasu, Traffic Tip Tuesday, as well as the various videos created to keep our public informed about what's going on with the City.

Hope everyone enjoys these updates and is having a great summer.

School Board Update from LHUSD Board President David Rose

This month, our school district has continued to make progress on key issues that reflect our shared values of responsibility, accountability, and student-centered education.

Implementing Arizona's New Cell Phone Law

We recently adopted a policy in compliance with HB 2484, which restricts student cell phone use during the entire school day—including class time, meals, and recess. Our board will be holding a special meeting to determine the final policies and procedures to ensure full compliance with the law. This step is aimed at creating a more focused, respectful learning environment while addressing real concerns from parents and staff.

Fighting for Fiscal Responsibility

When a proposal came forward to spend \$75,000 on locking phone storage bags, I raised concerns and encouraged the district to explore more cost-effective solutions. Enforcing the law shouldn't come at the expense of common sense or responsible use of taxpayer dollars.

Looking Ahead

The first day of school for the 2025–2026 school year is Thursday, July 31. We're looking forward to welcoming our students back and starting the year strong.

Gavin's leadership dilemma

Guess who runs California? Officially, it's the governor and the political class, i.e. the legislature. But it's actually the public sector unions. I guess that's what happens when they organize the vote drive and get the folks out to vote. Here is [the story](#):

Gov. Gavin Newsom (D-CA) is incapable of getting his employees to show up to the office more than two days a week. This is an indictment of his leadership and reveals a flaw that should be fatal to his presidential aspirations. It is also an indictment of the California Democratic Party, which has shown itself to be a wholly owned subsidiary of powerful government unions.

This March, just weeks before the state's Legislative Analyst's Office projected current and "persistent" deficits of between \$10 billion and \$20 billion a year, Newsom issued an executive order directing all agency heads to update telework policies to require staff to be in their offices four days a week rather than two days, as is now the case. Agency heads were given three months to get this done, with an implementation deadline of July 1.

California's government unions, SEIU Local 1000 most prominent among them, vowed to block Newsom's order, and many elected Democrats in Sacramento joined the fight on the unions' side. Several government employee unions filed grievances with the state, while others sued. The unions spent more than \$30,000 on billboards that were posted in Sacramento attacking Newsom for supposedly creating traffic jams by forcing workers to go to their place of work.

Sure enough, Newsom buckled under this pressure and capitulated. He delayed the return to work by a year, giving unions more time to flex their political muscles and prepare for another fight.

Government unions are big business in California. Combined, the California Teachers Association, California Federation of Teachers, California School Employees Association, American Federation of State and Municipal Employees, SEIU 1000, and other public safety unions have more than a million members in the state, paying more than a billion dollars a year in dues.

Between 15% and 25% of this money is spent maximizing the unions' political power, including direct donations to Democratic Party campaigns, ballot measures, political staff, lobbyists in Sacramento, and "issue advocacy." That comes to \$150 million of union dues spent every year influencing government policy.

No other special interest groups in the state come close to spending that kind of money and acquiring such influence – not Silicon Valley, not Hollywood, not the tourism industry. The government employee unions are a unified political machine. Not even the Democratic Party of California comes close to spending that kind of money to wield power.

No other group has that much influence? Who knew that such was the outcome of a one-party state dominated by public sector unions? They're in charge and Gavin knows it.

The larger issue is that it makes the governor look weak. At least, President Reagan fired the guys at the airport tower. It reminded me of something I heard back then when a friend from Europe was so impressed that a democratically elected president would fire union members. Reagan "has big ones" said he, and it wasn't a reference to his shoe size.

So Gavin continues picking fights over ICE and sanctuary cities. But the image of a weak leader, or the man who can't get his state workers to show up at the office, prevails.

Steve Miller Band cancels entire 2025 tour due to climate change

The Steve Miller Band unexpectedly canceled their entire North American tour recently, citing [bad weather](#).

That's right, the band is afraid to travel around North America due to climate change.

The 31-date tour, which was slated to begin on Aug. 15 in New York, had been expected to wrap up in Anaheim, Calif. on Nov. 8.

The Steve Miller Band has canceled all of our upcoming tour dates. No, we are not blaming it on the weather.

We are placing the blame squarely on the craven little prissy members of the band, precisely where it belongs. This is truly unprecedented cowardice—and idiocy if legit. However, I suspect it may have something to do with an expectation of poor ticket sales — or a combination of aging bodies and laziness.

But back to the USO tours. Comedian [Bob Hope](#) entertained the troops for nearly 50 years — from World War II, through Vietnam, to the Gulf War. Hope traveled the world, visiting remote outposts in Alaska, dangerous battle zones in Beirut and isolated battleships in faraway seas, all to put a smile on the faces of those in harm's way.

Country music superstar Toby Keith (rest in peace) performed a Memorial Day concert for nearly 4,000 service members in 2006 in the [Fallujah Chapel](#). And that was Keith's *second* visit to Fallujah. He also traveled there in 2004, just after the Marines took over the town considered so dangerous that the army had reportedly been pulled out. And he played two other venues on Memorial Day as part of the USO's Toby Keith Tour.

This announcement by the band is astounding in its virtue signaling cravenness.

And beyond idiotic.

I don't know where the band members live, but wherever it is, they probably have weather there, too. Neither flood, nor drought, nor heat, nor cold, nor twisters, nor hurricanes keep most other Americans from traveling and enjoying their lives. Or going to work.

So, if you happen to see a band member standing on the corner in, say, Winslow, Arizona, don't stop and pick him up. Don't even try to understand. [Take it easy](#). [These jokers](#) don't deserve it.

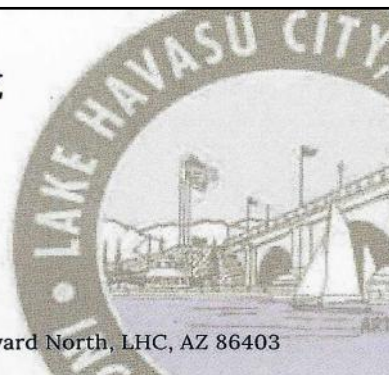

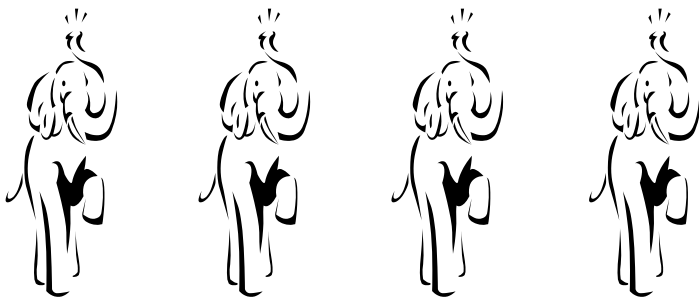
